Lift Station Issues: One pump has been removed for repairs, quoted cost of \$7,650.20. We do not have a timeline to reinstall the pump as of the this meeting. The remaining pump is struggling to keep up. Pressure keeps building in outlet pipe running between the lift station and Greenbriar One. The only thing in this line is an Air Release Valve that must be malfunctioning. RCM Utilities is working up an estimate to replace the valve.

Pool Issues: None of the pool pumps are currently in operation. One of the leg wires for the 220 volt system has been damaged, leaving the breaker panel without power for the pumps. Although only one wire needs to be replaced, it likely that all four wires will need be pulled.

Mr. Van Radoccia will be stepping down as the Association's Treasurer. Mr. Ray Michael, a former BOD Member, will be taking his place. These changes will officially take place at the February 6th Annual Meeting. Van expressed his gratitude to the rest of the Board, the manager, and all of the membership. There being no further business, Ms. Cynthia Tyler moved to adjourn with a second from Ms. Carol Ehninger. All were in favor, and the meeting adjourned at 10:53 AM.
